They will offer 5 hours of consultancy to the winner in addition to a participation right to the Rockstart Agrifood Selection Days and a VIP ticket to the Rockstart Community Day.

REFLECTING ON THE FIELD

[The conference programme](#) is the occasion to discuss the innovation trends of the nutrition and human and animal health sectors. It is divided into **three tracks**: The latest trends in food supplements innovation, innovation in finished food products, and the animal nutrition highlights. The first plenary session will reflect on food waste valorisation and circular food systems. This year the conference programme will integrate the question of petfood. **60 high-level speakers** will participate in the conferences.
